**Arjo - procurement was completed using a framework of available options with preferred options appraised by clinical users. A total replacement programme was completed in 2018 with a further review of replacement not expected until 2028+. This service is arranged with 3<sup>rd</sup> party contracted PPM provider.**

**2. Details for each Acute Hospital within the Trust - Pressure Mattress Supply Agreements or Contracts.**

**Name of current suppliers / Procurement Route (e.g. NHS Supply Chain or other) / End date of supply agreements or contracts**

**Direct HealthCare - purchased direct to obtain preferred hybrid advanced mattress. A total replacement programme is now complete having purchased mattresses and pumps in manageable quantities. With the shelf life of these products being 10 years, a further review**

**of replacement is not expected until 2026+. This service is arranged with the supplier under an annually renewable ProServe contract.**
